Ero Copper receives Vermelhos Mine Operating License, ramping up to full production

Vancouver, British Columbia – Ero Copper Corp. (the "Company") (TSX: ERO) is pleased to announce the issuance of the Vermelhos Operating License by the Instituto de Meio Ambiente e Recursos Hídricos do Estado da Bahia ("INEMA"), the governing environmental agency for the State of Bahia. The receipt of the Operating License allows the Company to commence full production at the Vermelhos Mine. Since August, as authorized under the Vermelhos Mine Installation License, the Company has conducted trial mining, transport and metallurgical test processing of ore from the mine.

Ero Copper Corp, headquartered in Vancouver, B.C., is focused on copper production growth from the Vale do Curaçá Property, located in Bahia, Brazil. The Company's primary asset is a 99.6% interest in the Brazilian copper mining company, Mineração Caraíba S.A. ("MCSA"), 100% owner of the Vale do Curaçá Property with over 39 years of operating history in the region. The Company currently mines copper ore from the Pilar underground mine, the Surubim open pit mine and has begun trial mining and processing at its newly constructed Vermelhos underground mine. In addition to the Vale do Curaçá Property, MCSA owns 100% of the Boa Esperança development project, an IOCG-type copper project located in Pará, Brazil.
